DURING 2023, HOSPICE OF NORTH IDAHO CARED FOR MORE THAN 1,176 HOSPICE PATIENTS. HOSPICE OF NORTH IDAHO PROVIDED BEREAVEMENT SERVICES TO FAMILIES OF HOSPICE PATIENTS AND COMMUNITY MEMBERS. MANY OF THE SERVICES PROVIDED ARE NOT REIMBURSED INCLUDING COMMUNITY BEREAVEMENT, KIDS CAMP, GRIEF AND LOSS PROGRAMS AND END OF LIFE COMMUNITY EDUCATION PROGRAMS.
